A. Scope of work

The purpose of this Terms of Reference is to appoint a service provider to supply Ba-Phalaborwa local municipality with implementation of GIS system. The intended GIS technology must be an enabler and a way to communicate and engage with community members. As part of the requirements, the system should enable a seamless data collection in the field through mobile applications. As a minimum the system should be an online system.

Geographic information system provides the capacity to collect, manage, manipulate, analyses and share location-based information. It is an integral part of the decision support infrastructure that can significantly contribute to planning and informed decision-making regarding service delivery. Geographic information system is a critical tool that support a number of municipal legislation requirements contained in the Municipal System Act (No.32 of 2000), the Municipal Structure Act (No. 117 of 1998), the Spatial Data Infrastructure Act (No.54 of 2003), the Promotion of Access to Information Act (No.2 of 2000) and the Property Rates Act (No.6 of 2004).

To ensure compliance and for the municipality provide quality information, it needs the GIS application to support and integrate various plans and policies, datasets in the best possible way to assist in decision making regarding town planning. One of the key strategies of the municipal Land Use Management System is to regulate and manage land development and enforce proper land use control measures, GIS is a great tool to achieve this and therefore it needs to be fully equipped and functional.

B. Scope of Works

The scope of work entails the supply, installation, and configuration of the GIS software for adopting a GIS centric approach to managing IDP projects reporting in the municipality and data collection. The GIS system should be easily accessible and user friendly to the Local Municipality employees. It is crucial for a system to be able to assist a Ba-Phalaborwa local municipality in the collection and verification of data both in the office and on the field.

The scope of work entails the below main components as described:

1. GEOSPATIAL SERVER (ENTERPRISE SERVER):

- Must have Distributed Web Feature Services capabilities to allows the municipality to disperse their data as necessary from central server to any other client.
- Must easily integrate with various GIS software currently being utilised in the market.
- On-premises server to allow full ownership of the infrastructure
- Should allow multi-user editing on a server environment.
- Flexible server software for mapping and analytics that allows you to easily manage your location-enabled data and brings a Web GIS into your infrastructure.
- Provides your organization the power to analyse, create, and share content to any device, anywhere.
- Transform database information into highly differentiated features displayed on a map
- Consume and serve data from external OGC services.
- Portal that enables Web GIS and allows members of your organization to search, organize, analyse, store, and share location-enabled content.
- Advanced sign-on capabilities.

2. GIS DESKTOP TECHNOLOGY

- Enables you to view, explore, analyse, edit, and share your maps and data.
- Publishing the existing data and Desktop GIS related vector data layers and schemas as OGC services i.e.WMS, WFS, etc to the web
- Connect directly to spatially-enabled database, both proprietary and open source.
- Ability to open different views at the same time.
- Access common geospatial file formats, computer-aided design (CAD) formats, shapefiles, PlanetGIS, Open source, KML etc.
- 3D Capabilities
- Create interactive maps and visually model spatial data.

The appointed service provider will also be expected to develop an easy-to-use mobile application that will be used for data collection, the mobile application should have both online and offline usage capabilities.

- Ability to take pictures as attachments.

Skills transfer should be done to all the relevant stakeholders who will be using both the Dashboard system and the mobile solution after implementation.

TAX CLEARANCE CERTIFICATE

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
