1.1. DETAILED SCOPE OF WORK

The service providers required must be practicing within the following category:

- Electrical Engineering Works- Infrastructure (CIDB Grading EP 4)

The purpose of the project is to acquire the services of a suitably qualified electrical service provider for Supply, delivery to site, installation, testing and commissioning of the following:

- 1) Supply and Installation of 216 new 200 W LED High Mast Luminaires as per specification on existing 30m High masts, as well as removal of existing luminaires
- 2) Supply and Installation of 432 new 30 W LED streetlight Luminaires as per specification on existing internal streetlights, as well as removal of existing luminaires
- 3) Transportation of old luminaires to demolishing site.
- 4) Testing and certifying the installation
- 5) Project Monitoring
- 5) Handing Over the Project to the Municipality
- 6) Providing a certificate of destruction (crushing) of all removed equipment
- 7) Project Duration is six (06) months, Guarantee and maintenance for twelve (12) months from date of handover, and 5 years for luminaires. (Factory guarantee)

TAX CLEARANCE CERTIFICATE

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean

that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations,

competitive tendering process or any other method envisaged in legislation;

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

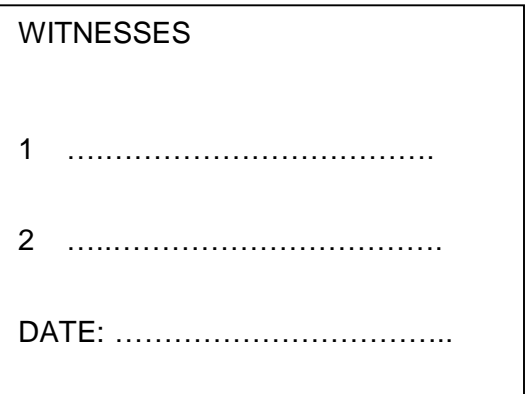

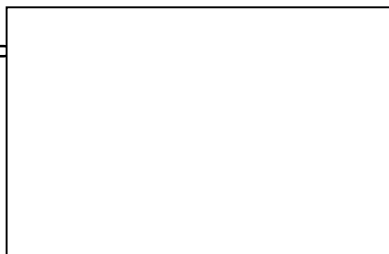
