1. INTRODUCTION

The Ba-Phalaborwa Local Municipality herewith invites bidders to perform a Value Added Tax (VAT) recovery for a period three (3) years. The period of appointment will be for a period of 3 years. Bids from suitable service providers will be evaluated according to the set criteria as set out in this document.

2. DESCRIPTION OF THE SERVICES REQUIRED

A. Confidentiality:

1. All documents and information relating to the municipality remains the intellectual property of the Ba-Phalaborwa Municipality and the bidder is prohibited from disclosing such information without prior consent of the municipality.
2. Bidders must be able to contain confidential information and may be required to sign an undertaking in this regard.
3. All documents that will be accessed by the bidder will be regarded as a confidential document and must be treated as such.

B. VAT Recovery:

1. Assist with the recovery of any tax credits from revenue authorities within reasonable time and costs.

2. Documenting and recording of all necessary recommendations regarding VAT recovery.
3. Formulate effective ways of VAT recovery.
4. Identifying all areas that need to be taken in to account for VAT recovery.
5. Check all expenditures incurred by the municipality which are VAT inclusive for previous five year and resubmit prior years VAT returns where necessary in order to recover prior years unrecoverable VAT Refunds.
6. VAT Contingency review for the 3 previous financial years.
7. Bidders will need to indicate how they will go about recovering VAT (Methodology) as points will be allocated for that as part of functionality evaluation.
8. Identify tax and system risks and exposures associated with operations, controls and provide mitigations for those risks,

C. VAT Submissions and SARS Engagements

1. Submit monthly VAT 201 return of the municipality to SARS. Assist municipality with the correct monthly VAT submissions to SARS,
2. Compile monthly schedules supporting the amounts declared on the monthly VAT 201 returns.
3. Attend to SARS queries on behalf of the municipality.
4. Review all municipal invoices to ensure that they are VAT compliant,
5. Address all SARS VAT queries and facilitate the SARS VAT audit process, including the provision of required explanations and supporting documentation up to the point of approval and payment of the refunds by SARS.

TAX CLEARANCE CERTIFICATE

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.
