


NOTE:

- Sizes above - calculated using 400mm deep units.
- 360mm units are also available but cannot be used with pull-out components.
- Tandem Bays (2,3,4 etc. Wide) are available in all combination of bays i.e. 2,3,4,5,6 etc. bays.
- Infinite possibilities are available dependent on floor space.


