1. BACKGROUND

Ba-Phalaborwa municipality through technical service department hereby requests appointment of consulting engineer/professional service provider and contractor for the rehabilitation of stormwater culvert at graveyard Selwane ward (Turnkey).

SCOPE OF WORK

The successful bidder shall execute and not be limited to the following:

Proposed Works

- The bidder is required to take the project through all six stages of Project life cycle as per ECSA guidelines Gazette vol.719 May 2025 no.52691

Project stages namely

- Inception
- Preliminary designs
- Detailed designs
- Documentations
- Contract administration and inspection (fulltime supervision)
- Close out
- Demolition of existing bridge structure
- Rehabilitate culvert structure with prefabricated floor slabs (2100mm x 2100mm RP-75S) including inlet and outlet slabs and wing walls
- Installation of Gabions
- Stone pitching including v-drains
- Earth drains
- Reinforced concrete works
- Installation of guardrails
- Installation of road signs
