1. BACKGROUND

According to the Municipal Systems Act (Act 32 of 2000), municipalities are required to establish a performance management system that aligns with their resources and circumstances, as well as the priorities, objectives, indicators, and targets outlined in their Integrated Development Plan (IDP). Furthermore, municipalities must foster a culture of performance management among their political structures, office bearers, Councilors, and administrative staff, ensuring that affairs are conducted economically, effectively, efficiently, and accountably.

Ba-Phalaborwa Local Municipality recognizes the need for an automated performance management system, along with training and system support services, to streamline the administrative processes of managing both institutional and individual performance, including cascading this down to lower levels. This performance management encompasses actions related to risk management. By implementing this automated system, Ba-Phalaborwa Local Municipality seeks to improve its overall efficiency and accountability, ultimately enhancing service delivery to its constituents. The initiative is a strategic step toward achieving sustainable growth and development within the municipality, positioning it as a leader in effective governance and public service excellence.

2. IMPLEMENTATION OF THE PERFORMANCE MANAGEMENT SYSTEM

1. The implementation of an automated organizational performance management system is essential for effectively monitoring, reporting, and evaluating the Integrated Development Plan (IDP) and Service Delivery and Budget Implementation Plan (SDBIP). This system should facilitate the following functions:
 - 1.1. The easy update of performance objectives,
 - 1.2. The upload of proof of evidence,
 - 1.3. Compilation of quarterly, mid-year and annual performance reports and
 - 1.4. The auditing thereof.
2. Detailed audit logs should be available for assurance purposes.
3. Implementation of an automated individual performance management system must facilitate the compilation of individual performance scorecards (performance contracts) for officials at various levels within the municipality. It must support the management of both quarterly and annual assessments. The individual performance management system must be integrated with the institutional system (SDBIP) to ensure alignment and cohesion across all levels where employee performance management has been cascaded.
4. Training the Performance Management team and other identified officials in the use of the system.
5. Training identified officials as "Train-the-Trainers" for the various modules included in the automated performance management system.
6. Providing ongoing system support that is managed through the system.

7. Training the Municipal Manager, Directors, Managers and data capturers in the use of the system.
8. Training the Assurance Providers (Internal Auditors) to use the system to conduct performance auditing.
9. Training the Risk Management team to use the Risk management functionality of the system.
- 3. THE AUTOMATED PERFORMANCE MANAGEMENT AND RISK SYSTEM MUST HAVE THE FOLLOWING FUNCTIONALITIES (AS A MINIMUM REQUIREMENT):**
 1. A Web based real-time system that is supported with the appropriate levels of security and data protection.

 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder.
6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However, communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation);
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit a bid;

(e) the submission of a bid which does not meet the specifications and conditions of the bid; or (f) bidding with the intention not to win the bid.

8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
