BACKGROUND AND PURPOSE OF THE BID

The Technical Services Department through PMU division hereby requests for appointment of a **pool of contractors for the following services:**

1. Panel of contractors for construction, repairs and maintenance of electrical infrastructure (building infrastructure) and new installation in Ba-Phalaborwa Municipality for a period of 36 months (GRADE 4-6 EP)

1. CIDB GRADING

1. The minimum grading for the panel of contractors for construction, repairs and maintenance of electrical infrastructures and new installation for the period of 36 months is GRADE 4-6 EP or higher

The contractor will be required to select for which grading they are bidding for and the company experience attached for the company should be aligned with the grading which the contractor seeks to be evaluated on.

- **Grade 4:** Up to R6 Million
- **Grade 5:** Up to R10 Million
- **Grade 6:** Up to R20 Million

TAX CLEARANCE CERTIFICATE

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
