## BACKGROUND AND PURPOSE OF THE BID

The Technical Services Department through PMU division hereby requests for appointments of a **pool of contractors for the following services:**

1. Panel of contractors for construction, repairs and maintenance of civil infrastructure and new installation in Ba-Phalaborwa Municipality for a period of 36 months.

### 1. CIDB GRADING

1. The minimum grading for the panel of contractors for construction, repairs and maintenance of civil infrastructures and new installation for the period of 36 months is GRADE 4-6 CE or higher

The contractor will be required to select for which grading they are bidding for and the company experience attached for the company should be aligned with the grading which the contractor seeks to be evaluated on.

- **Grade 4:** Up to R6 Million
- **Grade 5:** Up to R10 Million
- **Grade 6:** Up to R20 Million

### 2. EVALUATION CRITERIA

#### EVALUATION OF RESPONDED BIDDERS

The committee agreed that bidders should meet the requirements for the First Stage of Compliance before qualifying to the next or second stage of Evaluation Criteria

The project will be evaluated on a maximum point scored on functionality. In case of a tie, a draw will be used.

The municipality may negotiate with successful bidders on flat rates where such is plausible.

### **FUNCTIONALITY**

**NOTE: All company experience and project values submitted will be evaluated in accordance with the bidder's applicable CIDB grading designation. Where the total value of completed projects submitted is below the minimum CIDB grading requirement stipulated in this tender, the bidder will be allocated zero (0) points for that criterion.**

- Profile of Key Staff : 30 Points
- Company Experience : 60 Points
- Plant and Equipment : 10 Points

CV's of all proposed team must be accompanied by signed consent letter from incumbent and certified by SAPS

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
  - a. take all reasonable steps to prevent such abuse;
  - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
  - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
