1. INTRODUCTION

The purpose of this specification is to outline the scope, requirements, and deliverables for the development of engineering designs for the closure and rehabilitation of the Phalaborwa landfill (Phase 1). The project aims to ensure compliance with environmental regulations and sustainable waste management practices.

2. SCOPE OF WORK

The appointed consultant shall undertake the following tasks:

2.1. Site Assessment and Investigations

Conduct a detailed site survey, including topographical and geotechnical assessments.

- Assess the current waste composition, quantity, and landfill stability.
- Perform hydrological and hydrogeological studies to evaluate groundwater and surface water impacts
- Identify potential environmental risks and propose mitigation measures.

2.2. Engineering Design Development

Develop detailed engineering designs for landfill closure and rehabilitation, considering:

- Final cover system
- Drainage and stormwater management
- Leachate collection and treatment system
- Gas management system
- Vegetation and land restoration plan
- Site security and access control measures
- Building designs for staff office, ablution, composting facility and boardroom

Ensure compliance with South African National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) and relevant landfill closure and Rehabilitation guidelines.

Provide alternative design solutions with cost estimates for evaluation.

2.3. Environmental and Regulatory Compliance

- Prepare basic assessment report.
- Obtain necessary permits and approvals from relevant authorities.
- Develop a monitoring and maintenance plan post-closure.

- Conduct consultations with the local municipality, community representatives, and regulatory bodies.
- Address stakeholder concerns and incorporate feedback into the design.

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

- g. it adheres to the Prevention and Combating of Corrupt Activities Act 12 of 2004;
- h. it is solvent and in a position to continue doing business for the period stipulated in the contract after contract signature, if awarded a contract by Ba-Phalaborwa Municipality;
- i. it has zero tolerance to Fraud and Corruption and has appropriate procedures in place to prevent and respond to Fraud and Corruption in line with the legislation.

The Company understands that a false statement or failure to disclose any relevant information.

which may impact upon Ba-Phalaborwa Municipality's decision to award a contract may result in the disqualification of the company from the bidding exercise and/or the withdrawal of any offer of a contract with Ba-Phalaborwa Municipality.
