TECHNICAL SPECIFICATIONS

ASSESSMENT OF THE ELECTRICAL DISTRIBUTION NETWORK

1. BACKGROUND INFORMATION

- 1.1 Ba-Phalaborwa Municipality is a licensed distributor in terms of the Electricity Regulation Act No. 4 of 2006.
- 1.2 The municipality currently distributes electricity to Phalaborwa town and adjoining suburbs.
- 1.3 Distribution in a few areas outside towns is through wooden overhead power lines whilst the town distribution network is through underground cables.
- 1.4 The bulk of town end-consumer points are supplied through 11000/400 V mini substations.
- 1.5 The few rural end-consumer points are through 11000/240 V, 11000/400 V pole mounted and ground transformers.
- 1.6 The notified maximum demand is 22-MVA.
- 1.7 Calculated electricity losses (KWh) are currently 32.4%.

2. THE OBJECTIVE OF THE PROJECT

The objective of the project is to conduct technical assessment of the condition of the electrical distribution network and provide recommendations of remedial action required to mitigate any adverse findings of the investigations. The scope of the assessment should include the following areas:

- Electricity metering system and losses
- Electricity lockout systems and safe operating procedures
- Electrical protection systems
- Condition monitoring systems
- Cost of supply study and electricity tariffs
- Buildings and control rooms

3. SCOPE OF WORK

3.1 Electricity Metering and Losses

- 3.1.1 The service provider must investigate and report on the metering system in the distribution network.
- 3.1.2 A revenue enhancement study with a technical focus is required.
- 3.1.3 The service provider must determine the cause of electricity losses through investigation of the network including meter audits and billing.
- 3.1.4 Meter audit must include conventional domestic meters, bulk MV meters, LV meters and pre-paid meters.
- 3.1.5 The service provider must also obtain the Municipal electricity meter database and verify the allocation of meters to the correct property and that each property is linked to an account.
- 3.1.6 The final database must be provided in GIS format as well as in spreadsheet format and GPS co-ordinates of all meters.
- 3.1.7 The service provider must identify all measures that must be implemented to reduce both electricity and revenue losses.
- 3.1.8 The report must include the following information clearly indicating the impact of each on electricity losses:
 - Meters not on database (missing customers).
 - Meters on database but not being billed.
 - Meters with little or no consumption.
 - Inaccurate meters.
 - Tampered meters.
 - Damaged or defective meters.
 - Meters bypassed.
 - Unmetered points of supply.
 - Incorrect tariffs on points of supply.
 - Discrepancies between calculated and charged amounts.

3.2 Electrical Lockout Systems and Safe Work Procedures

- 3.2.1 Investigate and report on the lockout system that the municipality uses including safe working practices.
- 3.2.2 Compliance with the Occupational Health and Safety Act must also be included in the report.

3.3 Electrical Protection Systems

- 3.3.1 Conduct assessment of the protection system in the distribution network.
- 3.3.2 Assessment should include the settings and grading of the protection relays.
- 3.3.3 The status of the secondary plant must also be assessed.

3.4 Condition Monitoring Systems

- 3.4.1 Conduct assessment of all the electrical components in the distribution network and report on remedial action required for any adverse findings.
- 3.4.2 The assessment must include transformers, overhead power lines, cables, switching stations, mini-substations and meters.

3.5 Cost of Supply Studies and Electricity Tariffs

- 3.5.1 Assessment and recommendations on the status of the current electricity tariffs including their suitability and adequacy.

3.6 Buildings and Control Rooms

- 3.6.1 Assessment of the substation and switching station buildings housing the secondary plant including the fire protection, ventilation and alarm systems.
- The above scope is not exhaustive, and the service provider may include any other significant findings and recommendations where necessary.
 - Where applicable, the service provider should also provide budget estimates on the recommendations in the final report.


