INTRODUCTION

The Ba-Phalaborwa Municipality envisaged the **REHABILITATION OF CHIAMELO STREET AT PALESA NAMAKGALE ZONE D IN WARD 1**. The road to be rehabilitated is 1km long . The contractor will plan and execute all engineering, procurement, and construction activities needed to complete the project.

The contract shall cover inter alia the following:

- Demolish and clearing of the existing asphalt pavement
- Removing the damaged kerbs and replacing with new kerbs
- Preparation of the layer works.
- Installation of the Concrete drift
- Stone Pitch drain and Concrete v-drain
- Installations of road signs
- Road marking
- Finishing and Cleaning

PS-2 DESCRIPTION OF THE SITE AND ACCESS

2.1 Location of site

The limits of the project are as shown on the locality plan bound into the book of drawings to be received together with this document.

The site of works is located in Phalaborwa Namakgale of Latitude 23° 56'52.6"S
Longitude 31° 02'00,4"E

2.2 Access to site

Access to the site can be obtained from the existing Chiamelo street in Palesa Zone D Foskor . The contractor shall be responsible for the Construction of the drainage structure and rehabilitation of road and reinstatement of all damages caused by him or his agents/deliveries to vehicular access tracks and rights of way. No damage to fauna and flora located outside the limits of the road reserve will be permitted on the contract.

The contractor shall take cognizance of the aforementioned items concerning roads and tracks and allow for any costs in his bid under the relevant section in the bill of quantities.

PS-3 DETAILED SPECIFICATION FOR REHABILITATION OF CHIAMELO STREET AT PALESA NAMAKGALE ZONE D IN WARD 1

The project will be a turnkey Bid where by the Contractor will do the Engineering, procurement and construction contract, The selected contractor takes all the responsibilities, from design to the delivery of the project after its completion and undertakes all activities necessary to producing the project, including permits, plans, and construction.

- **Project Overview:** The project involves the rehabilitation of Chiamelo street , a 1km-long street in Palesa Zone D, Namakgale Foskor .

- **Contract Type:** This is a turnkey contract, where the contractor will be responsible for designing, constructing, and commissioning the project.

SCOPE OF WORK ROAD REHABILITATION

The contractor shall rehabilitate the existing road, including:

- Milling and removing the existing asphalt layer.
- Repairing and replacing damaged concrete pavement.
- Laying a new asphalt layer.

DRAINAGE IMPROVEMENT

The contractor shall improve the drainage system, including:

- Cleaning and clearing existing drains.
- Installing new drainage pipes and culverts.

UTILITY RELOCATION

The contractor shall relocate existing utilities, including:

- Electricity.
- Water.
- Sewerage.
- Traffic Management.
- The contractor shall implement a traffic management plan to ensure minimal disruption to traffic flow.

DESIGN REQUIREMENTS

- **Design Standards:** The contractor shall design the project in accordance with Ba-Phalaborwa Municipality standards and regulations.
- **Road Geometry:** The contractor shall ensure that the road geometry meets the required standards, including:
 - Gradient.
 - Camber.
 - Superelevation.
- **Drainage Design:** The contractor shall design the drainage system to ensure that it can handle the required stormwater runoff.

CONSTRUCTION REQUIREMENTS

- **Materials:** The contractor shall use materials that meet the required standards, including:
 - Asphalt
 - Concrete
 - Drainage pipes
- **Construction Methods:** The contractor shall use construction methods that minimize disruption to traffic flow and adjacent properties. COLTO construction methods shall be followed.
- **Quality Control:** The contractor shall implement a quality control plan to ensure that the work meets the required standards.

TESTING AND COMMISSIONING

- **Testing:** The contractor shall conduct tests to ensure that the road and drainage system meet the required standards.
- **Material testing :** The contractor must conduct a regular material testing to ensure Compliance with

- the specification that will satisfy the Municipal representative
- **Workmanship:** The Municipal representative will ensure that all the works is carried out to a high standard of workmanship.
- **Commissioning:** The contractor shall commission the project, including:
 - Final inspections.
 - Testing of drainage systems
 - Handover to the Client-Ba-Phalaborwa Municipality

SAFETY AND ENVIRONMENTAL REQUIREMENTS

- **Safety Plan:** The contractor shall implement a safety plan to ensure that the work is carried out safely.
- **Environmental Plan:** The contractor shall implement an environmental plan to minimize the impact of the work on the environment.
- **Personal Protective Equipment:** The contractor should ensure that all personnel wear their suitable personal protective equipment.
- **Traffic Control :** It is the responsibility of the Contractor to Implement a suitable and proper traffic control measures to ensure public safety on site.

CONTRACT ADMINISTRATION

- **Payment Terms:** The contractor shall be paid in accordance with the payment schedule.
- **Dispute Resolution:** Any disputes arising from the contract shall be resolved through Councillor of the ward.

WARRANTY AND MAINTENANCE

- **Warranty:** The contractor shall provide a warranty for the work, including materials and labor.
- **Maintenance:** It is the Responsibility of the Contractor to provide guidance on the maintenance requirements to ensure the roads remains functional and safe to the public.

3.1 Labour intensive construction works

The majority of work to be done under drainage structures have been identified for labour intensive construction works and shall consist inter alia of the following:

- Clear and grubbing
- Mass Earthworks
- V-drain
- Concrete mixing
- Concrete Drift

A. CIDB Grading

The service providers required must be registered with the CIDB and practicing within the following category:

- Civil engineering (CIDB Grading 4CE or higher)

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
