The Ba-Phalaborwa Municipality envisaged the completion of the INSTALLATION OF A

TRAPEZOIDAL STONEPITCH DRAIN IN POTGIETER STREET IN WARD 12. The drainage structure to be installed is 160m and 2m wide Trapezoidal, using stone pitching .The storm water drainage is located at the stream crossing Potgieter street in Phalaborwa town

The contract shall cover inter alia the following:

- Clearing and grubbing of the stream site including 160m on either side of the approaches of the Culvert at Potgieter street.
- Preparation of the layer works.
- Installation of the stone pitching using 110mm to 300mm dump rock
- stone and Concrete
- Provision of erosion of protection works
- Installation of guardrails
- Installations of road signs
- Finishing of the access culvert approaches

PS-2 DESCRIPTION OF THE SITE AND ACCESS

2.1 Location of site

The limits of the project are as shown on the locality plan bound into the book of drawings to be received together with this document.

The site of works is located in Phalaborwa town of Latitude 23° 95' 37.26"S Longitude 31° 12' 88.06"E

2.2 Access to site

Access to the site can be obtained from the existing Potgieter , Vonwiellig and Mellor streets .

The contractor shall be responsible for the Construction of a 160m drainage structure using stone pitch and reinstatement of all damages caused by him or his agents/deliveries to vehicular access tracks and rights of way. No damage to fauna and flora located outside the limits of the road reserve will be permitted on the contract.

The contractor shall take cognizance of the aforementioned items concerning roads and tracks and allow for any costs in his bid under the relevant section in the bill of quantities.

PS-3 DETAILED SPECIFICATION FOR CONSTRUCTING A 160M TRAPEZOIDAL DRAIN USING STONE PITCHING

1. GENERAL REQUIREMENTS

- Location: The drain will be constructed along the Potgieter Culvert; the drain will be approximately 160m long
- Designs: The drain will be Trapezoidal in shape with bottom width of 1.5m and side slope of 1:1.5.
- > Material: Stone pitching , Concrete and Geotextile fabric will be used for construction

2. SITE PREPARATION

- Clearing and Grubbing :Clearing of the area of the vegetation, debris, and Obstructions
- > Excavation: Excavate the drain to the required depth and width
- Geotextile Fabric :Laying of a geotextile fabric along the excavated drain , and ensuring it is securely fastened.

3. STONE PITCHING WORKS

- Stone selection: The minimum size of atleast 110mm to 300mm dump rock
- Placing of the stones: stone placement can be done from the bottom and working upward depending on the workmanship.
- Stone Bonding : the use of a 10mm thick layer of concrete to bond the stones together
- Stone Pitching pattern :Depending on the shapes of the stones , however for neatness purposes header and stretcher pattern may be used.

4. CONCRETE LINING

- **Concrete mix :** The use of a 1:2:3 concrete mix (Cement:sand :aggregates).
- Concrete Thickness: The Applying of a 50m thick layer Concrete to the stone pitching will be used
- Concrete finishing : Float and Broom system for the finishing of the concrete surface.

5. DRAINAGE AND OUTLET

- Drainage :Ensuring that the Drain is properly graded to allow for efficient water flow at all times.
- Outlet :Construction of a suitable outlet structure , a longer approach slab for proper cleaning of the existing culvert.

6. TESTING AND INSPECTION

- Visual Inspection : Inspection of the drain for any defects or irregularities will be done on a regular basis.
- Water testing: Testing of the drain with water to ensure it is functioning correctly will be done

7. SAFETY PRECAUTIONS

- Personal Protective Equipment: The contractor should ensure that all personnel wear their suitable personal protective equipment.
- Traffic Control : It is the responsibility of the Contractor to Implement a suitable and proper traffic control measures to ensure public safety as the site is a very

busy area that is near government facilities the department of home affairs , Labour department and Phalaborwa town Taxi rank.

8. QUALITY CONTROL

- Material testing : The contractor must conduct a regular material testing to ensure Compliance with the specification that will satisfy the Municipal representative
- **Workmanship:** The Municipal representative will ensure that all the works is carried out to a high standard of workmanship.

9. COMPLETION AND HANDOVER

- Completion: Completion of the drain construction must be withing the stipulated timeframe, no anticipated extension of time will be granted
- Handover: Handing over the completed and satisfying drain to the client and ensuring all necessary documentation is provided.

10. WARRRANTY AND MAINTENANCE

- Warranty: The Contractor must provide a warranty for the drain construction, ensuring any defects are rectified during a defects liability period.
- Maintenance: It is the Responsibility of the Contractor to provide guidance on maintenance requirements to ensure the drain remains functional.

3.1 labor intensive construction works

The majority of work to be done under drainage structures have been identified for labor intensive construction works and shall consist inter alia of the following:

- Clear and grubbing
- Mass Earthworks
- Stone pitching
- Concrete mixing
- Approche slab to the culvert
