#### 8. DELIVERY TIMEFRAME

The project is expected to be completed within 36 months from the date of signing of the service level agreement. The service provider will be required to commence with the assignment immediately upon appointment and must supply the municipality with a detailed revised work schedule with time frames.

#### 9. REPORTING

#### 10. PROJECT TEAM

#### TAX CLEARANCE CERTIFICATE
